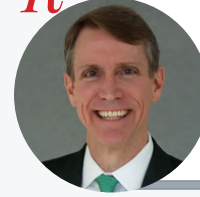

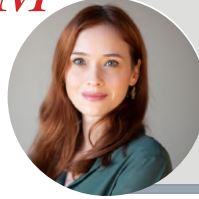

TURKEY: THE GREEN PRODUCTION BASE

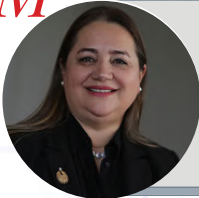
- How are rising energy prices, supply chain disruptions, increasing freight prices and container shortages affecting the global economy?

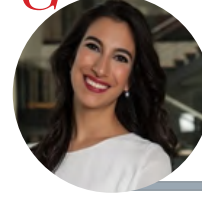

- In the field of Open Banking, how can it be possible to increase the transaction speed and maneuverability of banks through innovation and cooperation?
